VOLUNTARY ANNOUNCEMENT PARTICIPATING IN COVID-19 VACCINATION PROGRAM

This announcement is made by Union Medical Healthcare Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) on a voluntary basis.

BE FULLY PREPARED FOR COVID-19 VACCINATION

As the largest non-hospital medical service provider in Hong Kong (in terms of revenue in 2019 according to Frost & Sullivan), the Board is pleased to inform the Shareholders and potential investors that the Group is committed to safeguard the health and wellness of the public and fight against the pandemic with the residents together by fully supporting the Hong Kong Government’s COVID-19 vaccination arrangements.

Thirteen of the Group’s medical practitioners have registered to participate in the Hong Kong Government’s COVID-19 vaccination programme. The approved Sinovac Biotech “CoronaVac” vaccines injection will be provided to the five priority groups at the Group’s medical centers in Hong Kong:

1. Persons aged 60 years or above (a maximum of two carers who accompany people aged 70 or above can also receive vaccination);
2. Personnel in healthcare settings and those participating in anti-epidemic related work;
3. Residents and staff of residential care homes for the elderly / persons with disabilities;
4. Personnel maintaining critical public services; and
5. Personnel performing cross-boundary related work.

The Group possesses the vaccination experiences in Hong Kong Government’s “Measles Vaccination Mop-up Programme” and “Seasonal Influenza Vaccine Subsidy Programme”. The Group will actively cooperate with the Hong Kong Government in the implementation of the new COVID-19 vaccination service by leveraging on its advanced medical professionalism, outstanding medical environmental conditions and well-developed information technology infrastructure.

TOGETHER WE FIGHT AGAINST COVID-19

Since the COVID-19 pandemic began in Hong Kong, the Group has been committing to our missions, actively pursuing social responsibilities, and utilizing our medical expertise as well as staying at the forefront of the fight against the pandemic.

The Group has been participating in the provision of government-approved COVID-19 testing. To cater for public health and cross-border customs clearance needs, we have been providing different COVID-19 testing related services, including but not limited to laboratory testing programs for the Hong Kong Government, testing kit express services and electronic supporting reports. The Group has been offering remote consultation services (i.e. telemedicine) to satisfy the demands in chronically ill patients for regular checkups to reduce the risk of cross infection.

The Group will maintain close communication with the Hong Kong Government and the industry, and continue to actively fight against the pandemic with the public.
