### **GRANT OF SHARE OPTIONS**

The board of directors (the “**Board**”) of Union Medical Healthcare Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) hereby announces that on 11 April 2018, the Company granted 200,000 share options (the “**Share Options**”) to a grantee (the “**Grantee**”), subject to acceptance by the Grantee, under the share option scheme adopted by the Company on 19 February 2016 (“**Share Option Scheme**”).
