### **BUSINESS UPDATE**

This announcement is made by Union Medical Healthcare Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) on a voluntary basis for the purpose of updating the shareholders of the Company (the “**Shareholders**”) and potential investors on the latest business development of the Group.

#### **NEW HEALTH MANAGEMENT & HAIRCARE CENTRE IN CAUSEWAY BAY**

The board (the “**Board**”) of directors (“**Directors**”) of the Company is pleased to announce that on 18 March 2021, the Group has opened a new one-stop health management and haircare centre which provides a full range of comprehensive health screening, health product, health management and hair treatment services. The centre is located in the Group’s multi-service flagship medical centre at World Trade Centre in Causeway Bay, Hong Kong Island, with a newly leased gross floor area of approximately 12,800 square feet. After the establishment of this centre, the total service area of the Group in Causeway Bay increased to approximately 46,000 square feet.

#### **THIRD ADVANCED IMAGING SERVICE CENTRE**

In order to complement the Group’s existing services offering in Kowloon, the Group plans to set up an advanced imaging service centre with gross floor area of approximately 3,200 square feet in Tsim Sha Tsui in the first half of 2021. Together with the two existing advanced imaging service centres in Mong Kok and Yuen Long, the total gross floor area of the Group’s three advanced imaging service centres will be approximately 14,000 square feet.

Preventive and precision medicine has been one of the core businesses of the Group. To fulfill the demand for health management, haircare and advanced imaging services, the Group

establishes relevant service centres by organic growth to achieve further business synergy with diversified medical and healthcare business units among the enclosed ecosystem of the Group. The Board believes the aforementioned business expansion will become a growth driver for the Group's businesses, further consolidate the Group's position in the industry as a one-stop comprehensive healthcare and medical service provider, and effectively expand its healthcare and medical market share.

**Subject to the market condition, expansion may or may not proceed in the above manner. Shareholders and potential investors are advised to exercise caution when dealing in the shares of the Company.**
