POLL RESULTS OF ANNUAL GENERAL MEETING

HELD ON 21 AUGUST 2020

The Board is pleased to announce that all the resolutions as set out in the notice of the AGM dated 23 July 2020 were duly passed by the Shareholders by way of poll at the AGM held on 21 August 2020.

The board of directors (the “**Board**”) of Union Medical Healthcare Limited (the “**Company**”) is pleased to announce that all the resolutions as set out in the notice of the annual general meeting of the Company (the “**AGM**”) dated 23 July 2020 (“**AGM Notice**”) were duly passed by the shareholders of the Company (the “**Shareholders**”) by way of poll at the AGM held on 21 August 2020.

Unless the context otherwise requires, capitalised terms used herein shall have the same meanings as ascribed thereto in the circular of the Company dated 23 July 2020 (the “**Circular**”).

ATTENDANCE AT THE AGM

As at the date of the AGM, the issued share capital of the Company (the “**Shares**”) comprised 1,003,027,195 Shares, which was the total number of shares entitling the holders to attend and vote for or against all the resolutions at the AGM. Shareholders (in person or by proxy) holding an aggregate of 752,732,412 Shares, which represented approximately 75.05% of the total number of Shares, were present at the AGM.

There were no Shares entitling the holders to attend and abstain from voting in favour of the resolutions at the AGM as set out in Rule 13.40 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited (the “**Listing Rules**”) and there were no Shares requiring the holders to abstain from voting at the AGM under the Listing Rules. None of the Shareholders have stated their intention in the Circular to vote against or to abstain from voting on any of the resolutions at the AGM.
